APPEAL PROCEDURE

Prior to the start of the appeal's process, candidates are advised to have a thorough understanding of the eligibility requirements, evaluation of the selection criteria and application procedure at: https://www.planthealth.upv.es/web/apply/application-procedure/

Grounds for appeal must be duly justified. Late, incomplete or incorrect applications are not grounds for appeal. Please also note that PlantHealth receives a considerable number of applications and that the process is therefore very competitive.

The appeal procedure refers to the treatment of your proposal in the evaluation and eligibility check process. **It is not an automatic re-evaluation**. Please note that new information or clarifications that should have been included in the proposal will not be taken into account.

If you believe there has been an error in the evaluation of your application, please email <u>planthealth@upv.es</u> with your allegations within the **appeal period**: from 14 March 2024 to 22 March 2024. Each case will be considered on an individual basis and the appellant will be informed of the outcome as soon as possible.
